## Tennessee Governor Expected to Sign Bill Adopting Single Sales Factor and TCJA Bonus Depreciation

H.B. 323, passed House and Senate 4/20/23; News Release – Gov. Lee's Full 'Tennessee: Leading the Nation' Agenda Passes, Tenn. Office of the Governor (4/23/23). Pending legislation that is expected to be signed into law by Tennessee Governor Bill Lee includes provisions that, if enacted, would:

Adopt single sales factor apportionment for Tennessee franchise and excise tax purposes; and Conform with the federal bonus depreciation provisions (*i.e.*, involving Internal Revenue Code section 168) under the 2017 federal tax overhaul legislation known as the Tax Cuts and Jobs Act (*i.e.*, P.L. 115-97 or "TCJA") for Tennessee franchise and excise tax purposes.
