

## Income/Franchise: Montana DOR Explains Implementation of Newly Enacted Elective Pass-Through Entity Tax

*Montana Pass-Through Entity Tax*, Mont. Dept. of Rev. (6/8/23). The Montana Department of Revenue posted some implementation guidance on Montana's new elective entity level tax for certain pass-through entities [see S.B. 554, signed by gov. 5/19/23, and previously issued Multistate Tax Alert for more details on this new tax].
